#### Item (6) Training Center Power and addition

- a. Chief: A power study has been completed. Welding is done.
- b. A bid was submitted by Jimmy Brewer (bid Included in Minutes)
- c. The Jimmy Brewer's bid of \$16,425.00 consists of the cost to trench 500 ft., Install a 200-amp meter, 2 led exterior lights, 2 ceiling fans, 240 volt drop, and 4 post lights. If the Board decides to install this power plan to the Training Center, the best time would be January or February 2024. Those are the months with the fewest training days.
- d. Another option for the 4 post lights is to have Duke Power run the lights. This will need to be investigated.

# Item (9): 2000 Sutphen SP70 Quint from Greenville City FD

- a. The Chief informed the Board the 2000 Sutphen SP70 Quint from Greenville City FD was purchased for \$7482.37 at the Government Auction and has been delivered. Several pieces of apparatus were left on the truck. According to the sale Belmont can keep the equipment.
- b. The Quint will go out to be refurbed. The Chief is taking bids for the refurb and will submit those later. The Chief is also looking into the funding for the truck's refurb.
- c. Commissioner Bagwell asked if there is a grant for refurbing vehicles. The Chief thought the grants were only for new trucks.
- d. The Commission thought it would be a good idea to start a CD for a replacement engine in the future. The Board would like to discuss the CD options at a future meeting.

<u>Action:</u> Chief will obtain bids on Refurbing the 2000 Sutphen. Chief will investigate the options for the best CD to start Belmont's emergency fund.
