## *Item* (3) Approval of Minutes

## Item (4) Daniel Ponce

a. **From Chief**: Daniel Ponce has completed his probationary period. He is eligible to be paid at the Regular Rate plus the bilingual bonus.

<u>Action</u>: A motion was made by Commissioner Shirley to promote Daniel Ponce and raise his pay to the regular rate stated in the policy and procedure manual, plus the bilingual bonus of \$1000.00, Commissioner Cass seconded the motion, all were in favor (4,0).

#### **OLD BUSINESS**

Item (5) 55th Anniversary Open House on October 14, 2023

a. **From Chief Segars** the open house was a success. The turnout was wonderful. Using finger food allowed our patrons to stand and walk around to the different tables. Our goal was to get as much educational material into the hands of our citizens in the district. The Chief feels we accomplished this goal. We had a lot of informational materials distributed to the community. Events like this help the Community understand what Belmont does, the importance of what we do and safety measures to employ for their homes and businesses. These events also helped our ISO rating to help our department perform better.

# Item (6): 2000 Sutphen SP70 Quint from Greenville City FD/ Refurb, insurance and financing

- a. The Chief informed the Board the 2000 Sutphen SP70 Quint from Greenville City FD will go out to be refurbed as soon as the shop gets an opening to work on it.
- b. Many pieces of the truck will be refurbed, for example the Pump will have valves rebuilt, the electronic panel will be rebuilt and many more parts.
- c. Many parts will be replaced or bought new, for example the tires replaced, costing approximately \$7500.00, mirrors, side jacks, blue neon lights on ladder. The list of parts to be refurbed, replaced, or bought new will be drawn up with a quote.

# Continued Item (6): 2000 Sutphen SP70 Quint from Greenville City FD/ Refurb, insurance, and financing

- d. The Belmont team will review the quote to decide what parts are most necessary and how to best financially get the truck up to code.
- e. If totaled all our vehicles need an insurance policy that will replace the vehicle and the contents in entirety. The policy needs to be at the dollar amount required at the time of the accident to purchase a new vehicle and contents. Or to replace parts on the vehicle at the current cost of that part, meaning the cost at the time of the accident.
- f. The financing for the refurb and reconstruction of the Quint is being researched by Chief Segars. There are many options that need to be considered. He will discuss them at a future meeting.

<u>Action:</u> Chief will continue to obtain bids on refurbing the 2000 Sutphen. The Chief will continue investigating options for the best CD to start Belmont's emergency fund.

<u>Action:</u> The Chief is also seeking insurance prices for full replacement of the Trucks.
